Project Overview

Cambridge Zero Policy Forum report on the costs, risks and opportunities of the UK's potential to achieve net zero

The <u>Cambridge Zero Policy Forum</u> is working with <u>Dimitri Zenghelis</u> (CZ Policy Forum member and Special Advisor on The Wealth Economy at the Bennett Institute for Public Policy) on a report on the costs, risks and opportunities of the UK's potential to achieve net zero. The report will highlight that the potential costs and benefits of achieving net zero are a strong and complex function of policy choices, investments and how various actors respond to policies. Fundamental structural and systemic change will cover cities, land, energy, transport, industry and water. How these change and interact over the next two decades will be crucial to the whole shape of the UK economy, and of course to productivity and growth. This report will be compiled over the coming 12 months, and we anticipate running a series of multidisciplinary workshops to both shape the report and ensure policy impact. Through these workshops, the report will draw on the contributions of policy stakeholders and academics from a wide range of disciplines.

Key pieces of work we anticipate the project assistant will be undertaking in August-September include:

- Review outputs from policy workshops
- Conduct a literature review
- Support with references and citations
- Identify and present case-studies
- Depending on skill set, writing and editing content for the report
